Foreign Trade in Goods

February 2021

Tirana, March 17, 2021: On February 2021 the value of exports was ALL 25 billion, decreasing by 0.9 % compared with the same period of previous year and increasing by 4.4 % compared with January 2021. The value of imports was ALL 52 billion, increasing by 0.9 % compared with the same period of previous year and by 15.0 % compared with January 2021. This month the trade deficit is ALL 27 billion, increasing by 2.7 % compared with February 2020 and by 26.7 compared with January 2020.





Fig.1 Annual change in Foring Trade, February 2021 (%)

In the first two months of 2021, the value of exports was ALL 49 billion, increasing by 1.0 %, compared with previous year and the value of imports was ALL 98 billion, increasing by 4.3 % compared with previous year. Trade deficit was ALL 49 billion, increasing by 7.7 % compared with the same period of 2020.

The influence of the main groups in the annual change in exports:

In annual decrease of exports by 0.9 % this month, a negative contribution was given by the groups: "Textile and footwear" with -7.6 percentage point, "Leather and leather manufactories" with -0.5 percentage point, "Wood manufactories and article of paper" with -0.4 percentage point. While a positive contribution was given by the groups: "Construction materials and metals" with +4.9 percentage point, "Food, beverages, tobacco" with +1.9 percentage point, "Chemical and plastical products" with +0.3 percentage point.

Fig.2 Contribution of groups in annual change of exports, February 2021




Exports during the first two months of 2021 are increased by 1.0 % compared with the same period of previous year. The main groups that influenced more in annual increase of exports are: "Construction materials and metals" with +4.6 perecentage point, "Food, beverages, tobacco" with +2.1 percentage point and "Machinery, equipment spare parts" with +0.8 percentage point. "While a negative contribution was given by the group: "Textile and footware" with -4.9 percentage point, "Minerals, fuels, electricity" with -0.8 percentage point, "Wood manufactories and article of paper" with -0.5 percentage point.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 0.9 %, this month has mainly affected the groups: "Machinery, equipment spare parts" with +4.0 percentage point, "Chemical and plastical products" with +1.9 percentage point, "Food, beverages, tobacco" with +0.7 percentage point. While, a negative contribution was given by the groups: "Minerals, fuels, electricity" with -3.7 percentage point, "Textile and footware" with -1.6 percentage point, "Leather and leather manufactories" with -1.0 percentage point.





In the first two months of 2021, imports are increased by 4.3 % compared with the same period of previous year. The groups affected positivity in annual increase of imports, are: "Machinery, equipment spare parts" with +3.4 percentage point, "Chemical and plastical products" with +2.1 percentage point, "Construction materials and metals" with +0.4 percentage point. While a negative contribution was given by the group: "Leather and leather manufactories" with -0.8 percentage point, "Minerals, fuels, electricity" with -0.7 percentage point, "Textile and footwear" with -0.7 percentage point.

The performance of trade in goods by partner countries

In February 2021, countries with which Albania has had the highest increase of exports, compared to February 2020 are: Kosovo (29.0 %), Greece (23.2 %) and China (9.6 %). While, countries with which has had a decrease of exports are: Italy (11.1 %), Spain (45.6 %) and Germany (26.4 %).

In the first two months of 2020, countries with which Albania has had the highest increase of exports, compared to the same period of 2020 are: Kosovo (7.4 %), Greece (12.3 %) and China (46.4 %). While, countries with which has had a decrease of exports are: Italy (3.7 %), Spain (25.4 %) and Germany (26.1 %).

In February 2021, countries with which Albania has had the highest increase of imports, compared to February 2020 are: Italy (7.2 %), Turkey (11.6 %) and Germany (12.8 %). While countries with which has had a decrease of imports are: Greece (4.2 %), Poland (4.3 %) and Spain (33.9 %).

In the first two months or 2021, countries with which Albania has had the highest increase of imports, compared to the same period of 2020 are: Italy (9.8 %), Turkey (6.8 %) and China (9.6 %). While, countries with which has had a decrease of imports are: Greece (8.3 %), Switzerland (6.8 %) and Russia (52.8 %).




Fig.4 ForeignTrade in Goods by several EU countries, February 2021

Trade with the EU countries is 63.5 % of total trade. In February 2021, exports to EU countries occuped 73.6 % of total export and imports from EU countries occuped 58.7 % of total import. The main trade partners remain: Italy (32.3 %), Turkey (7.5 %), Greece (7.2 %) and Germany (6.8 %).

Trade with the EU countries, in the first two months of 2021 is 63.4 % of total trade. In this period, the share of exports to EU countries was 77.2 % of total export and share of imports from EU countries was 56.5 % of total import. The main trade partners are: Italy (32.7 %), Turkey (7.4 %), China (7.3 %) and Greece (7.2 %).

Methodology

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.

Member State of European Union: Belgium, Germany, France, Italy, Luxembourg, Netherlands, Denmark, Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia, Slovenia, Bulgaria, Romania, Croatia.

Monthly revisions

The data made available for the last month have an effect also on the revision of the previous months, because with the arrival of data for the last month there are also updated data for previous months as a result of administrative resource updates.
