


Producer Price Index

First quarter, 2021

Tirana, 09 June 2021: In the first quarter 2021, Producer Price Index reached 101.1 decreasing by 0.6 %, compared with first quarter 2020.

Producer Price Index, in the first quarter 2021, increased by 1.6 % compared with fourth quarter 2020.



Annual change: Producer Price Index in "Electricity, gas, steam and air conditioning" section decreased by 2.8 % compared with first quarter 2020. "Mining and quarrying" section in the first quarter 2021 decreased by 1.1 %. Within this section prices increased the most in "Extraction of crude petroleum and natural gas; auxiliary services" activity by 5.8 %, where the biggest impact was given by January. Within this section prices increased the most in "Paper printing and regrouping of recorded media" activity by 2.9 % followed by prices in "Manufacture of leathers and leather products" activity by 2.3 %.

Producer Price Index for Domestic Market: Compared with the same period of 2020 the index signed an increased by 0.2 %. The index in the "Manyfacturing" section signed a increased by 0.9 %.

Export price index: Compared with the first quarter of the previous year the index signed a decrease by 0.2 %. Prices decreased the most in "Electricity, gas, steam and air conditioning" section by 15.3 %.

Quarter changes: Producer Price Index increased by 1.6 % compared with fourth quarter 2020. Producer Price Index in "Mining and quarrying" section increased by 4.3 % compared with previous quarter. Within this section prices decreased the most in "Extraction of crude petroleum and natural gas; auxiliary services" activity by 7.9 %. Producer prices of products in "Manufacturing" section increased by 1.4 %. Within this section prices increased in "Metallurgy" activity by 6.0 %.

Producer Prices Index for Domestic Market: Compared with the fourth quarter 2020 the index signed a increased by 1.2 %. Prices increased the most in "Mining and quarrying" section by 3.3 %.

Export Price Index: Compared with the previous quarter the index signed an increased by 4.1 %. The index in "Mining and quarrying" section signed an increase by 10.6 %

Metodology

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Section B Extracting industry
- Section C Manufacturing industry
- Section D Electric power, water and gas
- Section E Water supply, treatment activities and waste management

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 – digit level and are published in two digit level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products 'weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products' weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2020 as base year (2020 = 100). Calculation's method used in compiling of this index is Laspayer chain – index. It means that each transaction will be compared with its previous year December price (y -1).

Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2020 in percent of the average price level during 2020. hence adjusting the average of 2020 to 100.
- The second term is the chained index movement from December 2020 to December y-1 (a product of yearly index links [short-term links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

Measures of index

The annual change measures the price change between the current quarter and the same quarter of previous year. This measures is responsive to recent changes in price levels but can be influenced by one – off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
