Foreign Trade in Goods

November 2021

Tirana, December 17, 2021: On November 2021 the value of exports was ALL 37 billion, increasing by 36.3 % compared with the same period of previous year and by 9.8 % compared with October 2021. The value of imports was ALL 81 billion, increasing by 44.4 % compared with the same period of previous year and by 5.0 % compared with October 2021. This month the trade deficit is ALL 43 billion, increasing by 52.2 % compared with November 2020 and by 1.1 % compared with October 2021.




Fig.1 Annual change in Foring Trade (%)


In eleven months of 2021, the value of exports was ALL 337 billion, increasing by 35.4 %, compared with previous year and the value of imports was ALL 713 billion, increasing by 31.1 % compared with previous year. Trade deficit was ALL 376 billion, increasing by 27.4 % compared with the same period of 2020.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 36.3 % this month, a positive contribution was given by the groups: "Construction materials and metals" with +17.9 percentage point, "Mineral, fuels, electricity" with +6.7 percentage point and "Textile and footware" with +5.5 percentage point.

Fig.2 Contribution of groups in annual change of exports November 2021




Exports during eleven months of 2021 are increased by 35.4 % compared with the same period of previous year. The main groups that influenced more in annual increase of exports are: "Construction materials and metals" with +14.7 percentage point, "Mineral, fuels, electricity" with +10.7 percentage point and "Textile and footwear" with +3.3 percentage point.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 44.4 %, this month has mainly affected the groups: "Minerals, fuels, electricity" with +22.8 percentage point, "Construction materials and metals" with +8.3 percentage point and "Food, beverages, tobacco" with 4.3 percentage point.

In eleven months of 2021, imports are increased by 31.1 % compared with the same period of previous year. The groups affected positivity in annual increase of imports, are: "Mineral, fuels, electricity" with +7.2 percentage point, "Machinery, equipment spare parts" with +6.3 percentage point, and "Construction materials and metals" with +5.5 percentage point.

The performance of trade in goods by partner countries

In November 2021, countries with which Albania has had the highest increase of exports, compared to November 2020 are: Italy (34.9 %), Kosovo (51.4 %) and Spain (35.6 %).

In eleven months of 2021, countries with which Albania has had the highest increase of exports, compared to the same period of 2020 are: Italy (24.3 %), Kosovo (48.5 %) and Spain (44.0 %). While, countries with which had a decrease of exports are: Ukraine (18.9 %) and Russia (9.6 %).

In November 2021, countries with which Albania has had the highest increase of imports, compared to November 2020 are: Italy (28.4 %), Turkey (72.8 %) and Greece (31.1 %). While, countries with which had a decrease of exports are: China (2.2 %) and SHBA (12.9 %).

In the first eleven months or 2021, countries with which Albania has had the highest increase of imports, compared to the same period of 2020 are: Italy (28.4 %), Turkey (48.1 %) and China (20.7 %). While, the country with which has had a decrease of imports is: Ukraine (10.1 %).




Fig.4 ForeignTrade in Goods by several EU countries November 2021

Trade with the EU countries is 58.0 % of total trade. In November 2021, exports to EU countries occuped 70.8 % of total export and imports from EU countries occuped 52.1 % of total import. The main trade partners remain: Italy (30.1 %), Turkey (8.0 %), Greece (7.2 %) and China (5.6 %).

Trade with the EU countries, in the first ten months of 2021 is 60.2 % of total trade. In this period, the share of exports to EU countries was 72.0 % of total export and share of imports from EU countries was 54.6 % of total import. The main trade partners are: Italy (30.1 %), Turkey (7.8 %), Greece (7.2 %) and Germany (6.5 %).

Methodology

Exports are goods destined to a third country. placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed. or are left in warehouse. under customs procedure of release for free circulation. inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident. before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.

Member State of European Union: Belgium, Germany, France, Italy, Luxembourg, Netherlands, Denmark, Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia, Slovenia, Bulgaria, Romania, Croatia.

Monthly revisions

The data made available for the last month have an effect also on the revision of the previous months, because with the arrival of data for the last month there are also updated data for previous months as a result of administrative resource updates.
