


Foreign Trade in Goods

April 2022

Tirana, May 17, 2022: On April 2022 the value of exports was ALL 42 billion, increasing by 46.6 % compared with the same period of previous year and decreasing by 11.9 % compared with March 2022. The value of imports was ALL 78 billion, increasing by 23.7 % compared with the same period of previous year and decreasing by 6.9 % compared with March 2022. This month the trade deficit is ALL 36 billion, increasing by 4.6 % compared with April 2021 and decreasing by 0.3 % compared with March 2022.

Fig.1 Annual change in Foring Trade (%)




In the first four months of 2022, the value of exports was ALL 162 billion, increasing by 48.8 %, compared with previous year and the value of imports was ALL 285 billion, increasing by 26.7 % compared with previous year. Trade deficit was ALL 123 billion, increasing by 6.0 % compared with the same period of 2021.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 46.6 % this month, a positive contribution was given by the groups: "Construction materials and metals" with +15.5 percentage point, "Textile and footwear" with +11.8 percentage point and "Mineral, fuels, electricity" with +9.0 percentage point.

Fig.2 Contribution of groups in annual change of exports April 2022




Exports during the first four months of 2022 are increased by 48.8 % compared with the same period of previous year. The main groups that influenced more in annual increase of exports are: "Mineral, fuels, electricity" with +16.0 percentage point, "Construction materials and metals" with +14.7 percentage point, and "Textile and footware" with +7.8 percentage point.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 23.7 %, this month has mainly affected the groups: "Minerals, fuels, electricity" with +12.5 percentage point, "Construction materials and metals" with +3.9 percentage point and "Food, beverages, tobacco" with +2.8 percentage point. While a negative contribution was given by the group: "Chemical and plastical products" with -0.5 percentage point.

In the first four months of 2022, imports are increased by 26.7 % compared with the same period of previous year. The groups affected positivity in annual increase of imports, are: "Mineral, fuels, electricity" with +11.2 percentage point, "Construction materials and metals" with +6.3 percentage point and "Food, beverages, tobacco" with +3.9 percentage point.

The performance of trade in goods by partner countries

In April 2022, countries with which Albania has had the highest increase of exports, compared to April 2021 are: Italy (70.1 %), Germany (98.2 %) and Greece (42.6 %). While, countries with which has had a decrease of imports are: Kosovo (12.9 %), Spain (82.0 %) and Switzerland (20.1 %).

In the first four months of 2022, countries with which Albania has had the highest increase of exports, compared to the same period of 2021 are: Italy (58.4 %), Germany (116.0 %) and Kosovo (30.4 %). While, countries with which has had a decrease of imports are: Spain (70.2 %) and Turkey (2.1 %).

In April 2022, countries with which Albania has had the highest increase of imports, compared to April 2021 are: Italy (16.5 %), Turkey (75.2 %) and Greece (37.2 %). While, countries with which has had a decrease of imports are: China (10.6 %), USA (29.1 %) and Switzerland (3.6 %).

In the first four months or 2022, countries with which Albania has had the highest increase of imports, compared to the same period of 2021 are: Italy (13.7 %), Turkey (59.2 %) and Greece (25.4 %). While, countries with which has had a decrease of imports are: Russia (6.4 %), USA (22.0 %) and Switzerland (25.3 %),




Fig.4 ForeignTrade in Goods by several EU countries April 2022

Trade with the EU countries is 61.0 % of total trade. In April 2022, exports to EU countries occuped 74.5 % of total export and imports from EU countries occuped 53.7 % of total import. The main trade partners remain: Italy (32.0 %), Turkey (10.6 %), Germany (6.9 %) and Greece (6.9 %).

Trade with the EU countries, in the first four months of 2022 is 61.0 % of total trade. In this period, the share of exports to EU countries was 73.4 % of total export and share of imports from EU countries was 53.9 % of total import. The main trade partners are: Italy (31.8 %), Turkey (8.9 %), Germany (7.0 %) and Greece (6.7 %).

Methodology

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed. or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost. insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country. or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.

Member State of European Union: Belgium, Germany, France, Italy, Luxembourg, Netherlands, Denmark, Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia, Slovenia, Bulgaria, Romania, Croatia.

Monthly revisions

The data made available for the last month have an effect also on the revision of the previous months, because with the arrival of data for the last month there are also updated data for previous months as a result of administrative resource updates.
