

# Results on Industrial Production Survey - PRODCOM

#### Year 2024

**Tiranë, September 26, 2025:** INSTAT publishes the results on the Industrial Production Survey (PRODCOM) according to the Prodcom List detailed at an 8-digit level, which is used in the European Union countries. This survey is done with an annual frequency and covers all active enterprises which operate in mining and quarrying and manufacturing and aims to provide information on the production and sale of industrial products made by enterprises that carry out their economic activity in our country. These statistics serve to make analyses of industrial products produced in the country.

## Production and sale of most important industrial products

During 2024 it is produced 716,435 tons of crude petroleum. The production of pig iron and steel reached the quantity of 343,925 tons, the production of chromium ores and concentrates reached the quantity of 588,047 tons, the production of cement reached the quantity of 1,944,140 tons. The production of non-alcoholic beverages and mineral and aerated waters was 6,215,967 hectolitres in 2024.



Note: Industrial products at 8-digit level do not necessarily represent all the amount of industrial products produced at economic activity level.

The sales value for the crude petroleum during 2024 was 29,903 million ALL, for the pig iron and steel was 20,229 million ALL, for the portland cement and other hydraulic cements was 19,219 million ALL, for the chromium ores and concentrates was 14,915 million. The sales value of non-alcoholic beverages and mineral and aerated waters was 15,712 million ALL in 2024.

Fig. 1 Sales value of industrial products, 2023-2024




During 2024, manufacture of food products accounted for 14.0 % of the total sales value of industrial products, from 12.4 % in 2023.

Manufacture of other non-metallic mineral products accounted for 13.2 % of total sales in 2024, from 12.5 % in 2023, while the manufacture of basic metals accounted for 12.4 % of total sales in 2024 from 13.4 % in 2023.

The Figure 2 presents the sales value of industrial products, according to the divisions of Statistical Classification of Economic Activities Rev.2 (NACE Rev.2).

# Methodology

The Industrial Production Survey (PRODCOM) is an annual survey, which purpose is to collect and produce statistics on the production and sale of industrial products carried out by enterprises in the Republic of Albania. The industrial product term refers to both products that have a physical dimension and industrial services.

PRODCOM survey covers all active enterprises which operate in Mining and quarrying and Manufacturing, respectively sections B and C of the Statistical Classification of Economic Activities in the European Union (NACE Rev. 2). This survey is based on a statistical classification (Prodcom List) containing about 4000 different types of products. The Prodcom list is detailed at the 8-digit level and is used in European Union countries. Industrial products at an 8-digit level do not necessarily represent all the amount of industrial products produced at economic activity level.

Structural business statistics are published according to the European Commission regulations:

- EU regulation 2019/2152 on European business statistics (EBS);
- EU implementing regulation 2020/1197 on technical specifications and arrangements for European business statistics;
- Classification of PRODCOM (Prodcom List) which is created through a separate Implementing Regulation.

#### **Definitions of basic variables:**

**Actual production** (in units of measurement as defined in the Prodcom List) refers to the production produced by the enterprise during the reference year.

**Sold production** (in units of measurement as defined in the Prodcom List) refers to the production produced by the enterprise during a certain period of time and sold during the reference year, regardless the time of production.

**Sales Value** refers to the invoiced amount from the sale of industrial products during the reference year, excluding value added tax.
