

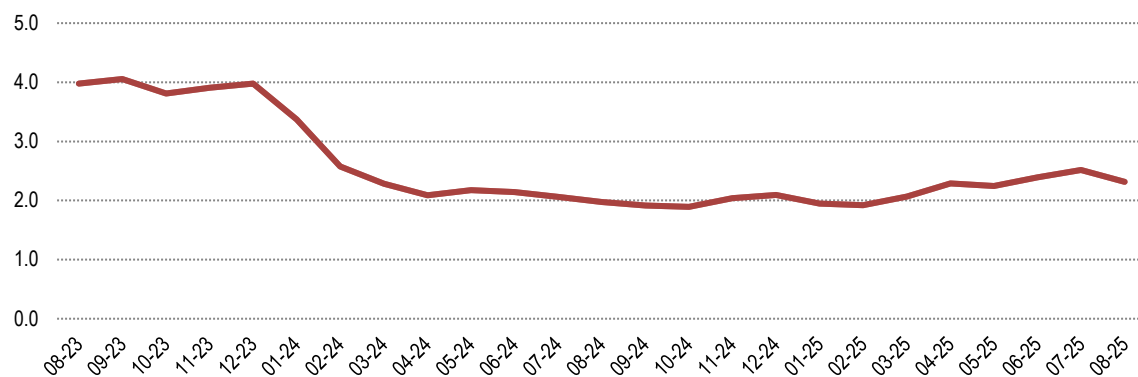
Consumer Price Index

August 2025

Tirana, on September 09, 2025: Consumer Price Index in August 2025 arrived 119.5, against December 2020 as reference period.

The annual rate of consumer price index in August 2025 is 2.3 %, a year before was 2.0 %. Compared with July 2025 the monthly change of consumer price index is +0.3 %.

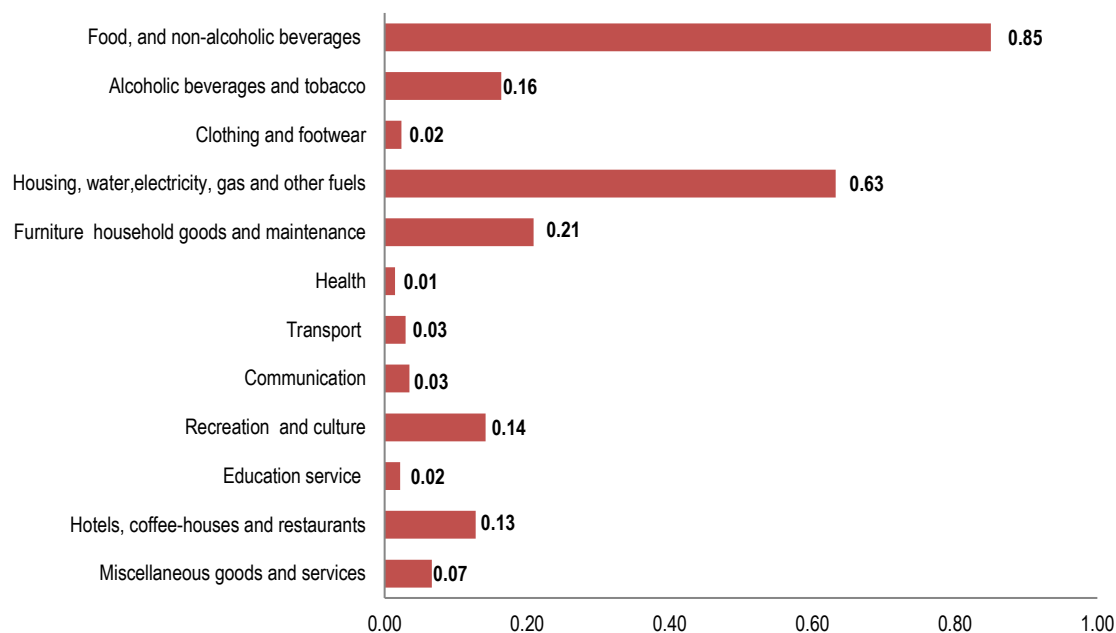
Fig. 1 Annual rate of consumer price index



Contribution of main groups in yearly changes of CPI: Annual growth rate in August was influenced mostly from prices of group “Food and non-alcoholic beverage” by +0.85 p.p., followed by “Housing, water, electricity and other fuel” “group contributed by +0.63 p.p.. Also, prices of “Furniture household goods and maintenance” group contributed by +0.21 p.p., prices of “Alcoholic beverages and tobacco” group by +0.16 p.p., prices of “Recreation and culture” group contributed by +0.14 p.p., prices of “Hotels, coffee-house and restaurants” group contributed by +0.13 p.p., prices of “Miscellaneous goods and services” group contributed by +0.07 p.p., prices of “Transport” and “Communication” groups contributed by +0.03 p.p. each of them, prices of “Clothing and footwear” and “Education service” groups contributed by +0.02 p.p. each of them, prices of “Health” contributed by +0.01 p.p..

Yearly rates of main groups: Compared to August 2024, prices increased the most in the “Recreation and culture” group by 6.3 %, followed by “Alcoholic beverages and tobacco” group by 3.3 %, “Housing, water, electricity and other fuel” by 3.1 %, “Furniture household goods and maintenance” by 2.8 %, “Food and non-alcoholic beverage” by 2.5 %, “Hotels, coffee-house and restaurants” by 2.2 %, “Communication” and “Miscellaneous goods and services” by 1.2 % each, “Education service” by 0.7 %, “Clothing and footwear” by 0.6 %, “Transport” by 0,5 % and “Health” by 0.4 %.

Within the food group prices of “Oils and fats” subgroup signed an increased by 6.5 %, followed by “Milk, cheese and eggs” by 3.6 %, “Meat” by 3.2 %, “Fish” by 2.4 %, “Fruits” by 2.1 %, “Vegetables included potatoes” by 1.3 %, etc.

Monthly rates of main groups: Compared with July 2025 prices of “Housing, water, electricity and other fuel”, “Recreation and culture” and “Hotels, coffee-house and restaurants” group increased by 0.5 % each, followed by “Furniture household goods and maintenance” group by 0.4 %, “Food and non-alcoholic beverage”, “Alcoholic beverages and tobacco” and “Clothing and footwear” by 0.3 % each, “Transport” by 0.2 %, “Health”, “Communication” and “Miscellaneous goods and services” by 0.1 % each.

Methodology

- Methodological changes

In January of each year some methodological changes and new developments were carried out in CPI:

- Update of weights: Weights are changed; they are now based on the average expenditure from 2023 Household Budget Survey.
- Update of basket: The list of goods and service content 331 products.
- Update of list of the outlets where the prices are collected is updated.

Started from January 2021, the consumer price index is calculated with the new base period. December 2020 is considered as the base period (December 2020 = 100).

- Definitions

The annual rate measures the price change between the current month and the same month of the previous year. This measure is responsive to recent changes in price levels but can be influenced by one-off effect in either month

The monthly rate measures the price change between current month and previous month. Although up-to-date it can be affected by seasonal and other effects.

The 12-month average rate compares average Consumer Price Indices ant the latest 12 month to the average of the previous 12 months.
