DECISION

No. 671, dated 7.11.2018

ON THE ESTABLISHMENT, OPERATION, AND DUTIES OF THE NATIONAL COMMISSION

FOR THE NOMENCLATURE

Based on Article 100 of the Constitution and point 4, of Article 24, of Law no. 17/2018, "On official statistics," upon the proposal of the Prime Minister, the Council of Ministers

DECIDED:

- 1. The establishment of the National Commission for the Nomenclature to carry out the updating, adaptation, and implementation of official economic and social classifications, in accordance with European and international nomenclatures.
- 2. The National Commission for the Nomenclature is chaired by the Director General of INSTAT and includes representatives from:
 - a) Ministry for Europe and Foreign Affairs 1;
 - b) Ministry of Internal Affairs 1;
 - c) Ministry of Finance and Economy 1;
 - ç) Ministry of Infrastructure and Energy 1;
 - d) Ministry of Education, Sports, and Youth 1;
 - dh) Ministry of Justice 1;
 - e) Ministry of Agriculture and Rural Development 1;
 - ë) Ministry of Health and Social Protection 1;
 - f) Ministry of Tourism and Environment 1;
 - g) Ministry of State for Entrepreneurship Protection 1;
 - gj) Bank of Albania 1;
 - h) National Employment Service 1;
 - i) General Directorate of Customs 1;
 - j) General Directorate of Taxes 1;
 - k) Social Insurance Institute 1:
 - 1) National Business Center 1;
 - ID INSTAT 2.
- 3. The representatives of the institutions, members of the Commission, are appointed by the heads of the institutions, according to the criteria and requirements presented by the Institute of Statistics, and notify INSTAT within 10 (ten) days.
- 4. For the preparation of meetings and coordination of the issues of the National Commission for the Nomenclature, a secretariat of the Commission is created, consisting of specialists from the Institute of Statistics. The rules for the operation of the secretariat are determined by the regulations approved by the National Commission for the Nomenclature.
- 5. The National Commission for the Nomenclature convenes upon the call of the chairperson. The meetings of the Commission are held according to the rules established in Law no. 8480, dated 25.8.1999, "On the functioning of collegial bodies of state administration and public entities."
- 6. The amount of remuneration for members of the National Commission for the Nomenclature, per meeting, is as determined in Decision no. 656, dated 31.10.2018, of the Council of Ministers, "On determining the remuneration amount of members of councils, boards, or permanent commissions of central government units."

- 7. The National Commission for the Nomenclature may establish working groups, according to its fields and needs, composed of all institutions included in the Commission or part of them. The rules for the operation of these groups and their level of responsibility are determined by a separate decision of this Commission.
- 8. The nomenclatures previously approved by the National Commission for the Nomenclature are approved by a separate decision of the Council of Ministers.
- 9. Decision no. 426, dated 15.5.2013, of the Council of Ministers, "On the establishment, operation, and duties of the National Commission for the Nomenclature," as amended, is repealed.
- 10. The Institute of Statistics and the institutions mentioned in point 2 are tasked with implementing this decision.

This decision enters into force after its publication in the Official Gazette.
