


Foreign Trade in Goods

August 2025

Tirana, September 19, 2025: In August 2025 the value of exports was ALL 25 billion, increasing by 12.9 % compared with the same period of the previous year and decreasing by 27.9 % compared with July 2025. The value of imports was ALL 67 billion, decreasing by 2.7 % compared with the same period of the previous year and by 19.6 % compared with July 2025. This month, the trade deficit is ALL 42 billion, decreasing by 10.2 % compared with August 2024 and by 13.5 % compared with July 2025.

Fig.1 Annual change in Foring Trade (%)




In these eight months, the value of exports was ALL 264 billion, increasing by 3.5 %, compared with the previous year and the value of imports was ALL 582 billion, decreasing by 2.1 % compared with the previous year. The trade deficit was ALL 318 billion, decreasing by 6.4 % compared with the same period of 2024.

The influence of the main groups in the annual change in exports:

In the annual increase of exports by 12.9 % this month, a positive contribution was given by the groups: "Mineral, fuels, electricity" with +18.9 percentage points, Machinery, equipment and spare parts" with +1.5 percentage points, etc. While a negative contribution was given by the groups: "Constructions materials and metals" with -6.7 percentage points and "Chemical and plastic products" with -0.6 percentage points.

Fig.2 Contribution of groups in annual change of exports, August 2025




Exports during these eight months have increased by 3.5 % compared with the same period of the previous year. The main groups that influenced more in annual increase of the exports are: "Mineral, fuels, electricity" with +10.0 percentage points, "Food, beverages, tobacco" with +1.1 percentage points, etc. While a negative contribution was given by the groups: "Constructions materials and metals" with -6.4 percentage points, and "Chemical and plastic products" with -0.7 percentage points.

The influence of the main groups in the annual change in imports:

In annual decrease of imports by 2.7 %, this month has mainly affected the groups: "Machinery, equipment and spare parts" with -1.3 percentage points, "Constructions materials and metals" with -1.2 percentage points, etc. While a positive contribution was given by the groups: "Mineral, fuels, electricity" with +1.0 percentage points, and "Food, beverages, tobacco", with +0.6 percentage points.





In these eight months, imports have decreased by 2.1 % compared with the same period of the previous year. The groups affected negatively in the annual decrease of imports, are: "Machinery, equipment and spare parts" with - 1.7 percentage points, "Constructions materials and metals" with -1.2 percentage points. While a positive contribution was given by the groups: "Food, beverages, tobacco" with +0.6 percentage points, "Mineral, fuels, electricity" with +0.5 percentage points and "Chemical and plastic products" with +0.2 percentage points.

The performance of trade in goods by partner countries


In August 2025, countries with which Albania had the highest increase of exports, compared to August 2024 are: Kosovo (94.6 %), Greece (19.0 %), Spain (4 times), etc. While, countries with which has had a decrease of exports are: Italy (19.6 %), Germany (16.1 %), etc.

In these eight months of 2025, countries with which Albania had an increase of exports, compared to the same period of 2024 are: Kosovo (75.0 %), Greece (10.4 %), Germany (6.0 %), etc. While countries with which has had a decrease are: Italy (10.8 %), China (5.8 %) and North Macedonia (30.9 %), etc.

In August 2025, countries with which Albania had the highest decrease of imports, are: Italy (9.8 %), Türkiye (18.1 %) and Germany (9.0 %). While, countries with which had an increase of imports are: China (18.3 %), Greece (6.1 %) and Kosovo (9.5 %).

In these eight months of 2025, countries with which Albania had the highest decrease of imports, compared to the same period of 2024 are: Italy (4.3 %), Türkiye (15.0 %), and Germany (7.0 %). While, countries with which had an increase of imports are: China (21.3 %), Greece (3.1 %) and Spain (14.0 %).

Trade with the EU countries is 48.8 % of total trade. In August 2025, exports to EU countries occupied 56.5 % of total export and imports from EU countries occupied 45.9 % of total import.

The main trade partners remain: Italy (18.8 %), China (12.9 %), Kosovo (8.6 %) and Türkiye (7.6 %).

Trade with the EU countries, in these eight months of 2025 is 55.8 % of total trade. In this period, the share of exports to EU countries was 66.2 % of total export and share of imports from EU countries was 51.1 % of total import.

The main trade partners are: Italy (26.0 %), China (9.7 %), Greece (7.6 %) and Türkiye (7.2 %).

Methodology

The publication of Foreign Trade statistics is subject to methodological revisions, which are based on

administrative data from customs authorities.

Exports are goods destined to a third country placed under customs export or outward processing arrangements

or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs

procedure of release for free circulation, inward processing or processing under customs control.

The cos, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country,

or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports

or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for

customs tariffs.

Member State of European Union: Belgium, Germany, France, Italy, Luxembourg, Netherlands, Denmark,

Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, Czech Republic, Estonia, Hungary, Latvia,

Lithuania, Malta, Poland, Slovakia, Slovenia, Bulgaria, Romania, Croatia.
